#### Case 1: Office

Longfellow Building near Dupont Circle fetches 28% of former value at auction

During November 2023, the Longfellow Building in Washington DC. recently sold at auction for \$21.2m about \$190 per sq ft for the 193, 400 sq ft building. This compares to the purchase price of \$76.3m in 2019. It was purchased by the lender BrightSpire Capital which provided \$65.4m of financing.

### Case 2: Multifamily

Lender gets \$12M for distressed South Side Chicago multifamily portfolio 70% of mortgage

During September 2023, A local investor picked up a 237-unit multifamily portfolio on Chicago's SouthSide for almost \$12.3 which was 68% of the \$17.6m mortgage in foreclosure sales that closed In August.

The portfolio consists of 10 buildings across the Grand Crossing, South Shore, Woodlawn and Washington Park neighborhoods, and was previously owned by the local real estate firm 5812 Group.

#### Case 3: Retail

Brookfield's Woodbridge Center is in Foreclosure on a \$225m Loan. Value declines 77% in 10 years

Brookfield's Woodbridge Center is in Foreclosure on a \$225m Loan.

As of June 2023, Woodbridge Center in North Jersey was in foreclosure proceedings. The mall is owned by Brookfield, defaulted on a \$225 million loan. The mall lost anchor tenant when Sears exited in 2020. The malls value has plummeted by 77% to \$86m from \$366 appraised for in 2014








### **Property Sector Value Declines**



#### Change to Property Prices From Recent Peak & Since Last Report







#### CRE Expected Returns vs. Corporate Bonds




### **Impediments:**
